

ROSLIN INNOVATION CENTRE GUIDELINES FOR USE OF CHARNOCK BRADLEY BULDING

WORKING ON EASTER BUSH CAMPUS

The continued impact of COVID-19 on our personal and work lives since March 2020 has been unprecedented.

The Scottish Government's Route Map provides an indication of the order in which we can carefully and gradually seek to lift restrictions in various aspects of our lives, including work and study.

To ensure we continue to reduce the risk of transmission of COVID-19 and under tougher restrictions, we must comply with the Government and University of Edinburgh guidance, and new procedures and guidelines are regularly circulated to help ensure your safety on Roslin Innovation Centre and the wider Campus.

ROSLIN INNOVATION CENTRE - STAFF, TENANTS AND VISITORS

Communication channels between the Roslin Innovation Centre administration team and tenants have remained open throughout and we continue to make every effort to ensure that this support is uninterrupted during normal working hours.

TENANT COMPANIES

Many Roslin Innovation Centre tenant companies will continue working remotely over the foreseeable future whilst remaining operational and are still very much open for business, collaboration and to explore opportunities.


ADVICE AND INFORMATION

Information has been prepared specifically for Easter Bush Campus and this includes Roslin Innovation Centre (RIC) tenant companies with their staff in mind, as well as all other University staff and student users of the Charnock Bradley Building facilities, in terms of precautionary measures within the working environment.

As of mid-April 2021, lockdown restrictions began to ease and vaccine roll out continues at a pace. In line with Scottish Government guidelines, we will move into Level 3 on 26 April.







Over the next few months, we will be going through a period where, if things go to plan, lockdown restrictions will continue to ease and we follow a framework from the Scottish Government indicating we will move to Level 2 on 17 May, with an expectation to move to Level 1 in early June and Level 0 by the end of June 2021.

Roslin Innovation Centre is accessible only to approved and named individuals via use of an electronic sign-in system, called 'Sign In App', which replaces the requirement to email Security (within normal working hours). This app is GDPR compliant and allows us to comply with Scottish Government and H&S rules for maximum occupancy, fire evacuation and to assist with Track-and-Protect, where necessary.

The University of Edinburgh is managing the risk of COVID-19 by ensuring suitable arrangements are in place, including measures to encourage physical distancing, hand/respiratory hygiene, limiting numbers in buildings etc.

ONE WAY SYSTEM AND SIGNAGE

For those that have returned to the building, you should all by now be using our 'sign in and out' app/iPad (see below) for entry and exit to/from Charnock Bradley Building (CBB) and you will have become familiar with our new one way system and signage.

Footfall within the building will be monitored closely and any changes to access patterns, as numbers accessing Charnock Bradley Building gradually increase.

SIGN IN APP - STAFF USER GUIDE

Our new electronic software, 'Sign In App', has been chosen to make the required sign-in process as quick and contactless as possible. The system uses a unique QR code to identify individuals during sign-in and out. Using a personal or works smartphone is the simplest way to sign-in at entry or exit points or an App (Companion App) from anywhere in the building.

You will have received advice on downloading the Sign In App and if you don't have a smartphone, a unique QR code will be provided, printed and laminated to scan at sign-in entry or exit points. See our website for PDFs and videos



FACE COVERINGS AND PERSONAL PROTECTIVE EQUIPMENT

Currently the use of face coverings on public transport, certain public indoor spaces e.g. shops, banks, libraries and indoor communal settings e.g. workplace corridors, is mandatory in Scotland. The Scottish Government has introduced these measures where physical distancing is difficult to implement. Evidence suggests that wearing a face covering may reduce the risk of transmission of COVID-19.

The University's guidance on face coverings was updated on 6 January 2021. It is now mandatory to wear face coverings in all University buildings and when moving around, plus in communal areas eg corridors etc and this includes movement around open plan office and lab space and the designated one way system at Roslin Innovation Centre.

Please be aware that there are certain conditions and hidden disabilities that may preclude persons from wearing face masks and we should ensure they understand and respect this.

The use of face coverings does not replace physical distancing or hand and respiratory hygiene measures (for example, washing hands and covering mouth if you cough), but could be used alongside these measures if desired.

Washing your hands is one of the most effective methods of preventing transmission of the virus. Where hand washing facilities are not readily accessible, hand sanitiser will be provided. You must sanitise your hands as soon as possible when entering a building and also wash/sanitise your hands frequently during the day.

PERSONAL PROTECTIVE EQUIPMENT – GENERAL GUIDELINES

The University aims to take all reasonable measures to comply with the physical distancing requirement and therefore it is not expected that general risk assessments will identify a need for additional personal protective equipment.


Staff and students are required to wear and store personal protective equipment as part of their normal activity and role. These requirements are documented in task/department specific risk assessment.

Our PPE Guidance document sets out general guidance on how we will use, store, launder or dispose of PPE to ensure we do not increase the risk of transmission of COVID-19 due to its use.

STAYING SAFE

The clear message from the Scottish Government is that 2 metre physical distancing should still be observed, so we will continue to conduct random weekly compliance checks to observe we are each respecting and practising this safe distancing rule.

University of Edinburgh Estates Department have implemented strict cleaning protocols with an enhanced cleaning regime (e.g. increased cleaning in shared spaces, and touch points) and including wipes and sprays in meeting rooms for use before and after meetings. This is obviously supported by both social distancing and hand washing regimes.

The University is also supporting staff, students and visitors, providing enhanced hygiene and face coverings advice. It is now mandatory to wear face coverings in all University buildings and when moving around, plus communal areas (corridors etc).

Roslin Innovation Centre and tenant company staff should continue to work from home when this is possible, to minimise the risk of personal contact and to reduce the potential for spread of the virus.

Reminder of the Scottish Government's FACTS policy:


- F Face coverings


OUT OF HOURS AND LONE WORKING

The Roslin Innovation Centre out-of-hours policy applies out with normal working hours:

- please use the Sign In App during normal working hours
- email security at <u>Campus.Easter.Bush@ed.ac.uk</u> on entry and exit if you are working out of hours (between 7pm and 7am Monday - Saturday and all day Sunday) and email when leave
- avoid long periods of lone working

If anyone needs to phone security for any other reason, you can call security on 517351.





GOODS AND STORES

With effect from 18 January 2021, Roslin Stores has reduced the time they are open for collections during the lockdown period.

Revised opening hours are: 11am - 12 noon and 1.30pm - 2.30pm, Monday to Friday for collection only.

Please do not place pressure on the Stores team by attending outside of these time slots.

Shipping of goods outwards will be restricted to critical shipments only and will be subject to the latest transport advice.

Deliveries and collections for RIC require to be coordinated directly by respective tenants with suppliers and pick-ups. Please direct them to the rear door entry of RIC, by the goods lift and arrange for tenant staff to meet directly with them there.

ON CAMPUS

The Central Services Unit will continue to operate - with contingency measures in place for a restricted service in order to support essential Roslin Innovation Centre lab operations, Roslin Institute laboratory experiments and clinical services should this be required. Autoclaving and waste handling services therefore continue to be undertaken for RIC labbased tenant companies.

Please do remember that working in buildings also requires other staff to be present, such as security and cleaning services, who are making a huge contribution to dealing with this situation.

From 3 May 2021, The View will reopen 7.45am until 3.30pm, Monday to Friday.


